ORDINANCE 2015-01

Community Plan Amendment & Zone Change 340 Smith Road
January 13, 2015

AN ORDINANCE OF THE CITY OF SEDONA, ARIZONA, APPROVING OF A MINOR COMMUNITY PLAN AMENDMENT TO MFMD (MULTI-FAMILY MEDIUM DENSITY) AND ZONE CHANGE TO RM-1 (MEDIUM DENSITY MULTI-FAMILY) TO ASSESSOR'S PARCEL 401-16-045A TO ALLOW THE OPERATION OF A BED & BREAKFAST USE AT 340 SMITH ROAD (DR. WILLIAMSON HOUSE, CITY OF SEDONA LANDMARK NO. 13); ESTABLISHING CONDITIONS OF SUCH REZONING; DIRECTING THE AMENDMENT OF THE ZONING AND COMMUNITY PLAN MAPS UPON COMPLETION OF ALL ZONING CONDITIONS SET FORTH HEREIN; PROVIDING THAT ALL ORDINANCES OR PARTS OF ORDINANCES OR ANY PART OF THE LAND DEVELOPMENT CODE IN CONFLICT WITH THE PROVISIONS OF THIS ORDINANCE SHALL BE REPEALED UPON THE EFFECTIVE DATE OF THIS ORDINANCE.

AN ORDINANCE OF THE CITY OF SEDONA, ARIZONA, AMENDING THE SEDONA LAND DEVELOPMENT CODE, ARTICLE 9, SECTION 918 (ACCESSORY DWELLING UNITS) BY DELETING SUBSECTION 918.13 (SUNSET CLAUSE) IN ITS ENTIRETY; PROVIDING THAT ALL ORDINANCES OR PARTS OF ORDINANCES OR ANY PART OF THE SEDONA LAND DEVELOPMENT CODE IN CONFLICT WITH THE PROVISIONS OF THIS ORDINANCE SHALL BE REPEALED UPON THE EFFECTIVE DATE OF THIS ORDINANCE; AND DECLARING AN EMERGENCY.

AN ORDINANCE OF THE CITY OF SEDONA, ARIZONA, AMENDING THE SEDONA CITY CODE, TITLE 12 (STREETS, SIDEWALKS, AND PUBLIC PLACES), CHAPTER 12.3 (PARKS AND RECREATION FACILITIES), BY AMENDING SECTION 12.30.150 (PROHIBITED SUBSTANCES) TO ALLOW LIMITED USE OF ALCOHOL ON CITY PROPERTY; PROVIDING THAT ALL ORDINANCES OR PARTS OF ORDINANCES OR ANY PART OF THE SEDONA CITY CODE IN CONFLICT WITH THE PROVISIONS OF THIS ORDINANCE SHALL BE REPEALED UPON THE EFFECTIVE DATE OF THIS ORDINANCE.
