The appeal is regarding an interpretation of the City of Sedona Land Development Code made by the Zoning Administrator (Community Development Director) pertaining to two Notices of Violation issued on November 10, 2015. These Notices outline code violations related to the expansion of a conditionally allowed commercial use on a residentially-zoned property and the use of three adjacent residentially-zoned properties for commercial purposes.


