I, Susan L. Irvine, City Clerk of the City of Sedona, Arizona do hereby certify:

That on July 9, 2018, 54 petition sheets containing what purported to be 639 signatures for Initiative Petition Serial Number INI 2018-01 were filed with the Sedona City Clerk's Office.

1. Signature sheets bearing secretary of state page numbers YAV-46 and bearing signatures of 6 persons appeared on signature pages that were required to be removed.
2. A total of 156 signatures (152 by Sedona City Clerk & 4 by Yavapai County Recorder) on the remaining petition sheets were found to be ineligible.
3. A total of signatures included in the random sample have been certified by the county recorders as ineligible at the time such petition was signed and a projection from such random sample has indicated that 77 more signatures are ineligible to appear on the petition.

Of the remaining 53 petitions containing 480 signatures, a total of 16 petitions containing 21 signatures were forwarded to the Yavapai County Recorder's Office for verification, and a total of 3 petitions containing 4 signatures were forwarded to the Coconino County Recorder's Office for verification. After conducting the random samplings, 17 of the 21 signatures forwarded to the Yavapai County Recorder's Office and 4 of the 4 signatures forwarded to the Coconino County Recorder's Office were determined to be qualified electors at the time of signing the petitions. Based on the results of these random samplings, 16% of the signatures would be considered invalid. The projected number of valid signatures, would therefore be 399 which is below the statutory requirement of 429 signatures. Therefore, INI 2018-01 would not qualify for the November 6, 2018 ballot.

After review of these petitions in accordance with A.R.S. §19-101 and §§ 19-121.01-19.121.04, the final outcome is as follows:

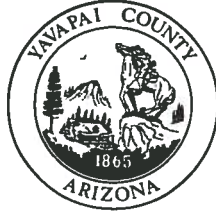
